

KCST 2018 SUMMER ENTERTAINMENT GIVE-A-WAY CONTEST RULES

Contest Give-A-Ways: Begin JULY 10TH 2018

Coast Broadcasting Company, FM 106.9 KCST will conduct the 2017 Summer Entertainment Contest Give-A-Ways substantially as described in these rules:

1. How to Enter:

Odds of winning vary greatly depending on number of entrants. Deadline for registration is 5pm on Thursday, **August 9th 2018**, four days prior to the Grand Drawing Tuesday, August 14 through 16, 2018 **ONE ENTRY – PER PERSON – PER DAY – PER LOCATION**. All entries must be on an official KCST Entry Form. Mechanically reproduced entries will automatically be deemed invalid. Valid contest entries must contain all information requested. All entry forms must be complete and/or legible. Incomplete and illegible forms will be deemed invalid.

How To Play: Winner(s) will be randomly selected from entries received at various Merchant Sponsor locations; Grand Prize drawings will be conducted at KCST Radio Center Studios from all remaining entry forms entered at all Merchant Sponsor locations by 3pm the day prior to the Grand Prize Drawings.
